The Barracuda NextGen Control Center **CONTROL** tab provides, among other things, real-time information about all Barracuda NextGen Firewall F-Series gateways the Barracuda NextGen Control Center administers. To access it, click **CONTROL** in the service bar.

CONTROL Tab Sections

The ribbon bar under the **CONTROL** tab contains a range of selectable icons for process handling and system actualization:

- **Status Map** – On the **Status Map** page, you can control and monitor ranges, clusters, and boxes that are managed by the Barracuda NextGen Control Center.
- **Geo Maps** – The **Geo Maps** page lets you add frequently used Barracuda NextGen Firewall F-Series appliances and tunnels to be displayed in a geographic map interface. From this page you can also access network information and routing tables.
- **Configuration/File Updates** – The pages displayed under these tabs provide an update status overview of all available Barracuda NextGen Firewall F-Series gateways, including a detailed view on the processes that are active. From here you can manage the box configuration changes that were made on the Barracuda NextGen Control Center and send updates to the Barracuda NextGen Firewall F-Series units.
- **Sessions** – On the **Sessions** page, you can access information about the sessions of your Barracuda NextGen Firewall F-Series gateways.
- **Barracuda Activation** – The **Barracuda Activation** page provides information about the license activation status of managed Barracuda NextGen Firewall F-Series gateways.
- **Floating Licenses** – The **Floating Licenses** page lets you manage licenses that are active and available for managed Barracuda NextGen Firewall F-Series gateways.
- **Statistics Collection** – The **Statistics Collection** page provides information about collected statistics from your Barracuda NextGen Firewall F-Series gateways.
- **Remote Execution** – On the **Remote Execution** page, you can execute non-recurring tasks like removal of unwanted files or termination of processes on your Barracuda NextGen Firewall F-Series boxes.
- **Scanner Versions** – The **Scanner Versions** page provides detailed information about the currently active virus scanner engine and virus scanner patterns.
- **Firmware Update** – On the **Firmware Update** page, you can execute software updates on administered Barracuda NextGen Firewall F-Series boxes.
- **Update Tasks** – The **Update Tasks** page displays the status of update tasks that were created in the software update process
