

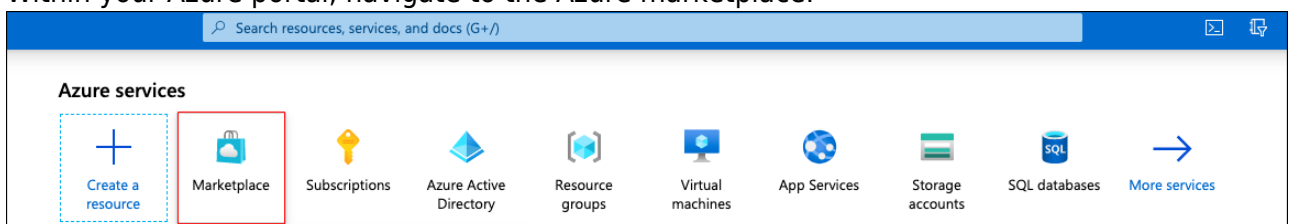

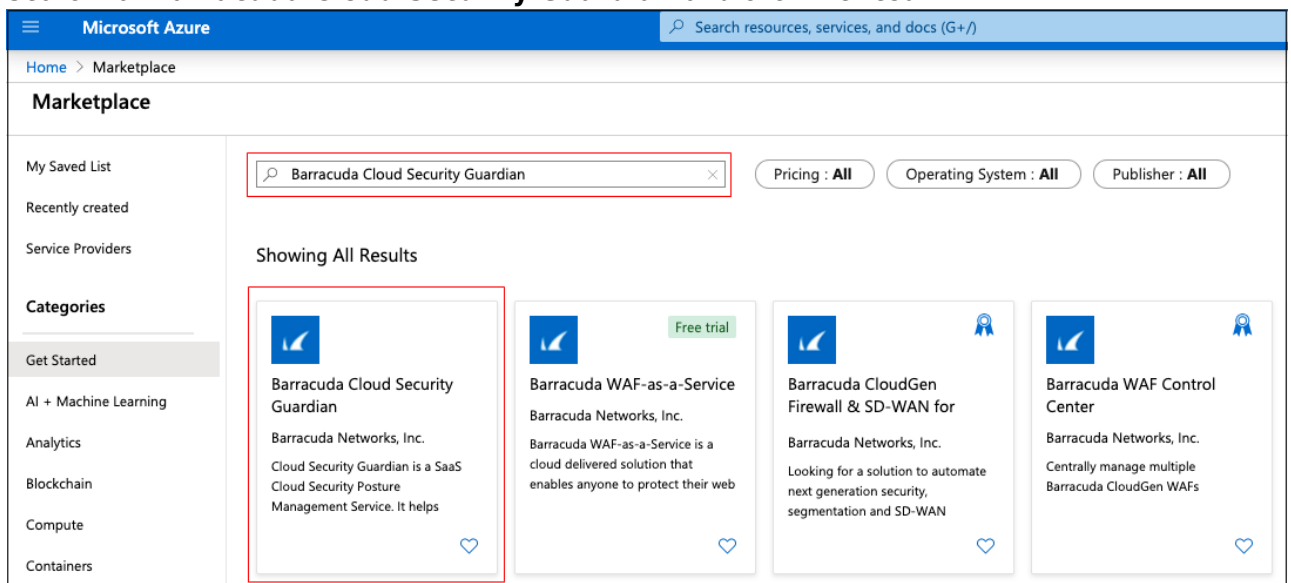
When you are ready to stop using Barracuda Cloud Security Guardian through Azure, unsubscribe from Azure so you are no longer billed by Azure.

To unsubscribe:


1. Navigate to portal.azure.com and sign in.


