

Reported Email Tracker (BETA)


When working with a Barracuda Email Protection product, you might report an email as having been Incorrectly Blocked (false positive) or Incorrectly Delivered (false negative). These reports are automatically reviewed by the intelligence built into the Barracuda Threat Data Platform and by the Barracuda Threat Analysis Team. After Barracuda Networks evaluates any perceived threats in your reported email, you will receive a status update to let you know the determination about your reported item. The status update email you receive lists the results of Barracuda Networks' analysis.

If you report multiple emails, they are all handled in one daily status update email.

The Reported Email Tracker will benefit end users that utilize the Enhanced Feedback capability to report emails to Barracuda Networks. The capability is designed to send a daily digest email to users to inform them of the status of their submission.

When you report emails to Barracuda Networks, you are contributing to our capability to detect and prevent attacks.





During the BETA phase, our systems will primarily rely on fingerprint-based blocks to assess potentially harmful emails. This approach allows us to collect valuable data and insights.

However, it is important to note that fingerprint-based blocks may not cover all scenarios adequately. In the upcoming GA (General Availability) release, Barracuda Networks will introduce machine learning based capability to automatically block similar emails submitted by users, which is a parallel initiative aimed at providing enhanced protection for our customers.

We appreciate your collaboration in our BETA phase as we work to improve our effectiveness in safeguarding your email communication.

Incorrectly Delivered	Message appears to be dangerous.	Extortion, Domain Impersonation, Brand Impersonation, Business Email Compromise, Conversation Hijacking, URL Phishing, Spear Phishing, Lateral Phishing, or Malware. For details, see Explanation of Reason Reported .
	Message is unwanted or trying to sell goods or services.	Scamming, Spam, or Bulk Email. For details, see Explanation of Reason Reported .
Incorrectly Blocked	Message is from a requested mailing list or newsletter.	No threat: This is an email from a service you requested.
	Message is from a known business.	No threat: This is an email you want to receive, from a business you trust.
	Message is from a known sender.	No threat: This is an email you want to receive, from a sender you trust.

Barracuda Impersonation Protection users

Barracuda Email Gateway Defense users

If you reported an email as either Incorrectly Blocked or Incorrectly Delivered through Barracuda Email Gateway Defense, you might have changed your Domain Policies or Sender policies accordingly.
