Barracuda WAF-as-a-Service

- [Form Protection](#) - Determine which features apply to each portion of your application.
 - Privileged account protection - Watches for signs of account takeover.
 - GraphQL security - Secures your GraphQL APIs.
 - JWT validation - Uses the received JSON Web Token (JWT) to validate the authenticity of the client sending HTTP requests and the token claims.

- The following protections are all now configured using the [Form Protection](#) component:
 - Brute force protection - This was previously included as part of DDoS prevention.
 - Data theft protection - The configured rules are now applied using [Form Protection](#).
 - File upload protection - This incorporates the previously separated Advanced Threat Protection (BAPT) and Virus Scanning components.
 - Credential attack protection - This was previously included as part of Bot Protection.
 - Login form protection - This was previously included as part of Bot Protection.
